Introduction

This document defines the requirements for evaluating and validating a law enforcement agency's reporting of incident data for the Wyoming- Incident-Based Reporting System (WY-IBRS)

Agencies must demonstrate that their records management system (RMS) can generate valid incident submissions to the Wyoming Division of Criminal Investigation (DCI). This is done by putting the RMS through a series of test cases. These test the RMS and its:

- ability to handle WY-IBRS business rules and workflow scenarios
- compatibility with system and technical specifications and requirements

Certification

Success in testing puts an agency on the path to certification. Certification ensures the quality of data submitted to the DCI. During the certification process, an agency can submit incident data to the repository in its test environment. To become certified, an agency must achieve an error rate of less than 4% over three consecutive months.

Once certified, an agency's RMS must maintain its high level of data quality (i.e., an error rate of less than 4%). Failure to do so can lead to de-certification.

Agencies that upgrade their RMS or change vendors must go through a recertification process with the new or upgraded software.

Submit incidents that result in a Wyoming Repository generated NIBRS compliance business rule warning that can be corrected on resubmission. Warnings warn users that:

- incorrect data was submitted,
- submitted data was not stored, or
- submitted data was truncated.

Example: an Aggravated Assault (UCR Offense Code 13A) with a Type Weapon or Force Involved code of “40” (Personal Weapons)

- **Type Weapon/Force Involved** – up to three per offense
- **Automatic Weapon Indicator** – values of “11A” (automatic firearm), “12A” (automatic handgun), “13A” (automatic rifle), “14A” (automatic shotgun), or “15A” (automatic other firearm) for Type Weapon/Force Involved; up to two per offense

Submit an incident with multiple offender(s) and victim(s) using each of the following Person Age Data values:

1. **Age Code** – an enumerated list; the following values should be used:
 - a. “00” (unknown)
 - b. “BB” (7-364 days old)
 - c. “NB” (1-6 days old)
 - d. “NN” (under 24 hours)
2. **Person Age** – an exact age
3. **Age Range** – a range of minimum to maximum age

Only one type of value is allowed per person.
